

Opt in, Activate & Use a Cashback Offer Prize Draw – Terms & Conditions

1. Who can enter?

This Prize Draw (the "Draw ") is open to Lloyds, Halifax or Bank of Scotland personal debit card holders and Visa primary credit card account holders.
And who are UK resident and 18 +.

2. Overview

The Draw opens on 19th August 2026 and will close at 23:59 on 30th September 2026 'Promotional Period'. Entries received after the closing date will not qualify. **Remember: only spend what you can afford.**

'We' means Lloyds Bank plc.

3. The prize

There are 100 prizes of £50 to be won. You can only win once.

4. How to enter the Draw

- 1) Click 'Everyday' tab in your home menu
- 2) Scroll down and select 'Rewards' for Lloyds, 'Cashback Extras' for Halifax or 'Everyday Offers' for Bank of Scotland
- 3) Click 'Cashback' tab
- 4) Activate the 'Opt in, Activate & Use a Cashback Offer Prize Draw' in app.
- 5) Then activate and use a cashback offer within '**Offers**' section as explained in the cashback offer conditions before **30th September 2026**.

If you have more than one eligible debit card or credit card with Lloyds, Halifax or Bank of Scotland, you only need to activate the Draw once.

For credit cards, only the primary cardholder can be entered into the Draw.

5. Are there any cashback exclusions?

Cashback earned through Lloyds Travel bookings, Lloyds Apple Store, other prize draws, or any product campaigns that sit outside the '**Offers**' section are excluded and will not count as eligible cashback for this promotion.

6. How many entries will I receive

You will receive one entry for each eligible cashback offer used during the Promotional Period. Some of the cashback offers are multi use and will earn you an entry each time you use them. You must spend at least the minimum amount specified each time and agree to any cashback conditions.

Illustrative example (for guidance only):

1 cashback offer used = 1 Draw entry

2 cashback offers used = 2 Draw entries

5 cashback offers used = 5 Draw entries

Where the primary credit card holder has activated a cashback offer, eligible transactions made by any additional cardholders will contribute towards earning cashback. And earn an entry to the Draw.

7. Joint account specific terms

Where an account is held jointly, each account holder may enter the Draw individually. To qualify for an entry, each account holder must activate the Draw and use at least one eligible cashback offer during the Promotional Period.

8. How the winners are chosen

The winners will be the first 100 entries drawn at random from all eligible entries received before the closing date. A computer process will be used to produce verifiably random results. The winners will be selected within the first 7 days of the Draw closing.

A reserve list will also be selected if any of the winners are not eligible to claim the prize.

9. How we announce the winners

We will publish or make available information indicating that a valid prize took place – ordinarily the winner’s surname and county and, if applicable, the winning entry. We can cancel, suspend or modify this promotion without telling you beforehand because of:

- Legal or regulatory issues;

- Any other reason beyond our reasonable control.

If this happens, we will put a notice on our App or Website as soon as possible.

We will always act reasonably.
